Staff Summary: Equipment No. 5706 is due for replacement in light of its age and daily use in harsh Landfill conditions. The Board of Supervisors ("Board") has already approved the purchase of the Ford F-550 cab and chassis that will replace Equipment No. 5706. This proposed purchase will upfit that cab and chassis for use as the new Landfill service truck. This requested purchase was planned for and was funded as part of the approved Fiscal Year ("FY") 2024 Capital Improvement Vehicle Replacement Program.

Staff Summary: Equipment No. 7912 has not passed any applicable threshold for refurbishment or replacement, but parts associated with its track have worn to an extent that they require repair and replacement. Although Equipment No. 8000 qualifies for replacement or refurbishment due to age, it requires only a partial refurbishment. The work proposed under this Contract will extend the life of both pieces of equipment. These requested purchases were planned for and are funded as part of the approved Fiscal Year ("FY") 2024 Capital Improvement Vehicle Replacement Program.

Staff Summary: This is an annual grant that provides funds for the TriNet Narcotics Task Force personnel in both Carson City and Douglas County. The project is funded through the Nevada Department of Public Safety, Office of Criminal Justice Assistance. The award will continue to partially fund one deputy sheriff each in Carson City and Douglas County and operational funds used for drug interdiction operations. The upcoming grant period is January 1, 2024, through December 31, 2024. The proposed interlocal agreement is the mechanism through which to pass the grant funding on to Douglas County. As this is an annual grant, staff is also seeking authority to accept the grant and enter into the interlocal agreement, on substantially the same terms, in 2025 and 2026. A member has resigned creating a vacancy for one of the Hotel/Motel Industry positions. bond holders. Both City staff and the auditors will provide information relating to financials, the audit procedures and the results of those procedures concerning the ACFR.

The total budget for the project is \$313,570, 75% of which (\$235,178) will come from HMGP funds and 25% of which (\$78,392) will come from the required local match. Click Here for Staff Report
